EDINBURGH RUGBY COMPETITION TERMS AND CONDITIONS

1. The Promoter

The promoter is Scottish Rugby Limited (trading as Edinburgh Rugby), Hive Stadium, Scottish Gas Murrayfield, Edinburgh, EH12 5PJ.

2. The competition

- 2.1 The title of the competition is "Fly a Fan Home".
- 2.2 To enter the competition, supporters are required to complete the "Fly a Fan Home" form and explain why they or someone they nominate should win the opportunity to be flown home for the Edinburgh Rugby vs Glasgow Warriors game on Saturday 30 December 2023.

3. How to enter

- 3.1 The competition will run from 12noon on Thursday 30 November 2023 (the "**Opening Date**") to 12noon on Thursday 7 December 2023 (the "**Closing Date**") inclusive.
- 3.2 All competition entries must be received by the Promoter by no later than 12noon on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 3.3 To enter the competition, entrants must send a completed entry form, by the Closing Date.
- 3.4 The Promoter will **not** accept:
 - (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - (b) proof of posting or transmission as proof of receipt of entry to the competition.
- 3.5 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.
- 3.6 The competition entries will be judged by a panel of judges based on the best-written and most compelling explanation. The decision of the panel of judges (acting reasonably) will be final.

4. Eligibility

- 4.1 The competition is only open to all residents in the UK aged 18 years or over, **except**:
 - (a) employees of the Promoter or its holding or subsidiary companies;
 - (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or
 - (c) members of the immediate families or households of (a) and (b) above.
- 4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.

- 4.3 The Promoter will not accept competition entries that are automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications) or incomplete.
- 4.4 There is a limit of one entry per person.
- 4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
- 4.6 Competition entries cannot be returned.

5. The prize

- 5.1 The prize is as follows: A return flight from a major UK airport to Edinburgh Airport for two persons, one nights' accommodation in Edinburgh, transport to/from Edinburgh Airport to the accommodation, and two hospitality tickets to Edinburgh Rugby vs Glasgow Warriors on Saturday 30 December 2023.
- 5.2 The prize is provided by Gulliver's Sports Travel Limited (the "Supplier").
- 5.3 The prize is for two persons to travel by airplane on economy class to Edinburgh for a one-night stay in Edinburgh on either the Friday 29 December 2023 or Saturday 30 December. The Supplier shall in its sole discretion select the hotel accommodation. The prize does not include travel insurance, the cost of transfers to and from the departure airport, food and drink, spending money, tax or personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winner(s).
- 5.4 You will be responsible for ensuring that you and any person travelling with you are available to travel and hold valid passports, any necessary visas and travel documents for the holiday in question on the travel dates specified. Dates once notified to the travel agent cannot be changed.
- 5.5 Prizes are subject to availability. The Promoter reserves the right to substitute the prize with a prize of equal or greater value.
- The Promoter reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the Promoter's control makes it necessary to do so.
- 5.7 The prize is not negotiable or transferable.
- 5.8 In order to claim the prize you must submit an entry via the form provided (*here*).

6. Winners

- 6.1 The decision of the Promoter is final and no correspondence or discussion will be entered into. The Promoter will contact the winner personally as soon as practicable after the Announcement Date, using the telephone number or email address provided with the competition entry.
- The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will send the surname and county of major prize winners and, if applicable copies of their winning entries, to anyone writes to the Promoter's registered address (enclosing a self-addressed envelope) within one month after the Closing Date of the competition.

6.3 If you object to your surname or winning entry being published or made available, please contact the Promoter. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

7. Claiming the prize

- 7.1 If you are the winner of the prize, you will have three days from the Announcement Date to claim the prize by referring to the details of how to claim in condition 5.8. If you do not claim the prize by this date, your claim will become invalid.
- 7.2 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within three days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
- 7.3 The Promoter does not accept any responsibility if you are not able to take up the prize.

8. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

9. Ownership of competition entries and intellectual property rights

9.1 You agree that the Promoter may, but is not required to, make your entry available on its website and any other media, whether now known or invented in the future, and in connection with any publicity of the competition. You agree to grant the Promoter a non-exclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights in the competition entry and any accompanying materials, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry and any accompanying materials for such purposes.

10. Data protection and publicity

10.1 The Promoter will only process your personal information as set out in our Privacy Policy as found on our website. See also condition 6.2 and condition 6.3, with regard to the announcement of winners.

11. General

- 11.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the competition.
- 11.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
- 11.3 These terms and conditions are governed by Scots law. If any entrants to this promotion wish to take court proceedings, then they must do this within the courts of Scotland.
