

EDINBURGH RUGBY COMPETITION

TERMS AND CONDITIONS

This Edinburgh Rugby Competition is organised by Scottish Rugby Limited, trading as Edinburgh Rugby.

When you enter this Competition, you agree to the following Terms and Conditions.

1. The Promoter

The Promoter of this Competition is Scottish Rugby Limited, trading as Edinburgh Rugby, a company incorporated in Scotland with registered number SC132061 and having its registered office at Murrayfield, Edinburgh EH12 5PJ ("**the Promoter**").

2. The Competition and how to enter

- 2.1. These Terms and Conditions apply to the "**Edinburgh Rugby Competition**" ("**the Competition**") being promoted on the Promoter's social media platforms.
- 2.2. Each day the Competition is live (see conditions 2.3 and 2.4 for opening and closing dates), a stress ball shall be hidden in Edinburgh by the Promoter ("**Competition Day**"). To enter the Competition, Entrants (defined at condition 3.1) must find the stress ball, take a selfie with it and either share the selfie to their Instagram Story tagging @edinburghrugby or share it via Direct Message on Instagram with @edinburghrugby or send it via email to community@edinburghrugby.org. Any entries submitted to the Promoter in any other manner or medium will be disqualified from the Competition. Only one entry per person is permitted.
- 2.3. The opening date for Competition entries is 4 August 2026 at 9am. Entries must comply with the conditions set out in conditions 2.2 and 3 and any entries that do not comply (in the sole opinion of the Promoter) will be disqualified from the Competition.
- 2.4. The Competition will close on 8 August 2026 at 5pm ("**the Closing Date**"). Entries received after the Closing Date will be automatically disqualified from the Competition.
- 2.5. The Promoter accepts no responsibility for entries not successfully completed, lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
- 2.6. Five (5) winners will be chosen over the duration of the Competition, with one (1) winner being chosen on each Competition Day. The winner of each Competition Day will be the first person who shared their selfie on their Instagram Story tagging @edinburghrugby, shared their selfie via Direct Message on Instagram with @edinburghrugby or emailed their selfie to community@edinburghrugby.org.
- 2.7. For help with entries please contact the Promoter on community@edinburghrugby.org or @edinburghrugby on Instagram.
- 2.8. By submitting a Competition entry, you are agreeing to (a) be bound by these Terms and Conditions; (b) to enter the Competition; (c) if you are a winner, to your name and image being recorded and published for promotional purposes by the Promoter or its authorised representatives and to allow the Promoter to comply with its obligations set out at conditions 5.4 and 5.5.

3. Eligibility

- 3.1. An "**Entrant**" is a person submitting an entry to the Competition, in accordance with condition 2.2.

- 3.2. The Competition is not open to employees of the Promoter or their immediate family or any third party directly associated with the administration of the Competition.
- 3.3. Entrants must be over 18 years old and resident in the United Kingdom.
- 3.4. In entering the Competition, the Entrant confirms that they are eligible to do so and to claim the Prize (as defined in condition 4 below) if they are a winner. The Promoter may require Entrants to provide proof that they are eligible to enter the Competition.
- 3.5. The Promoter will not accept Competition entries that are:
 - a) automatically generated by computer;
 - b) completed by third parties or in bulk;
 - c) illegible, have been altered, reconstructed, forged or tampered with;
 - d) photocopies and not originals; or
 - e) incomplete.

4. The Prize

- 4.1. Each winner will receive one (1) category 2 Edinburgh Rugby season ticket for the 2026/2027 season ("**the Prize**").
- 4.2. The Prize does not include transport, food and drink, spending money, tax or other personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winners.
- 4.3. The Prize is non-transferable or exchangeable and cannot be taken as cash.
- 4.4. The Prize shall be supplied by the Promoter.
- 4.5. The Promoter reserves the right to replace the Prize with an alternative prize of equal or higher value if circumstances beyond the Promoter's control make it necessary to do so.
- 4.6. The decision of the Promoter regarding any aspect of the Competition is final and binding and no correspondence will be entered into about it.

5. Notification of winning entry

- 5.1. Each Competition Day, a winner, selected in accordance with condition 2.6, will be notified by the Promoter via Direct Message on Instagram or by response to that winner's Instagram story, or by response to their email, that they are a winner. The Prize or instructions on how to receive the Prize will be sent to the winners by the Promoter within 24 hours of being notified of their win.
- 5.2. If a winner does not respond to the Promoter within twenty four (24) hours of being notified by the Promoter or if a winner is unable to accept any element of the Prize due to ineligibility, the Prize in its entirety will be withdrawn and the Promoter will be entitled to select another winner in accordance with the process set out at condition 2.6.
- 5.3. The Prize may not be claimed by a third party on behalf of a winner.
- 5.4. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will send the surname and county of the winners' to anyone who writes to the Promoter at the address set out in condition 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the Competition.
- 5.5. If you object to either or both of your surname and, county being published or made available, please contact the Promoter at community@edinburghrugby.org In such circumstances, the

Promoter will not provide the information to members of the public, but must still provide the information to the Advertising Standards Authority ("ASA") on request by the ASA, to comply with our legal obligation to do so.

6. Data protection

- 6.1. As part of submitting an entry to the Competition, Entrants are required to submit certain personal details, including their name, Instagram handle and postcode.
- 6.2. The legal basis for which the Promoter will collect personal data in respect of Competition Entrants are (i) its legitimate interest of administering the Competition, and (ii) to comply with its legal obligations in respect of Competition.
- 6.3. The Promoter will use the personal data of Entrants as follows:
 - 6.3.1. to contact the winners and to send the Prize to them;
 - 6.3.2. to contact an alternative winner and to send the Prize to them if a winner cannot be contacted within a reasonable time; and
 - 6.3.3. to comply with the legal obligation to provide the winners' surname and county in response to requests for this information from third parties, subject to conditions 5.4 and 5.5.
- 6.4. The Promoter will comply with the Data Protection Act 2018 and the UK General Data Protection Regulation when collecting and otherwise processing personal data in connection with this Competition. Any such personal data will be processed in accordance with the [Privacy & Cookies Policy - Edinburgh Rugby](#).

7. General

- 7.1. These Terms and Conditions and this Competition are governed by the laws of Scotland. By entering into this Competition each Entrant agrees to submit to the exclusive jurisdiction of the Scottish courts.
- 7.2. Entrants to the Competition are deemed to have accepted and agreed to be bound by these Terms and Conditions upon entry to the Competition.
- 7.3. The Promoter reserves the right to disqualify any Entrants that breach these Terms and Conditions or any entries that, in the sole opinion of the Promoter, are in any way obscene, violent, abusive, discriminatory, defamatory, fraudulent or otherwise unlawful or would damage the reputation of the Promoter. Where the Promoter disqualifies any Entrants in accordance with this condition 7.3, the Promoter shall remove any affected entries from the Competition.
- 7.4. The Promoter reserves the right to cancel this Competition at any time. The Promoter reserves the right to amend these Terms and Conditions without notice by posting changes to [Home - Edinburgh Rugby](#). The Promoter will only notify Entrants of changes if required to do so by law.
- 7.5. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any Entrant or accept any liability for any loss, damage, personal injury or death occurring as a result of entering the Competition or taking up the Prize except where it is caused by the negligence of the Promoter or that of its employees, agents or distributors. Your statutory rights are not affected.
